TRAFFIC IN OPIUM AND OTHER DANGEROUS DRUGS.

A. GENERAL.

I. Laws and Publications.

No new legislation on dangerous drugs was passed by the Legislative Council of St.Kitts and Nevis during the year 1942, nor were any regulations or orders made regarding the same.

III. Control of International Trade.

1. The import certificate system has worked satisfactorily and there has been no difficulty as regards the import of drugs into the Presidency.

4. There has been no export of dangerous drugs from the Presidency.

V. Illicit Traffic.

There are no known drug addicts in the Presidency. There were no prosecutions under the law in force.

X. Internal Control of Manufactured Drugs.

1. There is no manufacture in St. Kitts and Nevis.
2. There is no opium smoking in St. Kitts and Nevis. The persons permitted to be in possession of opium and other dangerous drugs are the authorities of the 3 Public Hospitals and of the Leper Home, medical practitioners and 6 licensed dispensing druggists.
