X. Internal Control of Manufactured Drugs.

4. Trade and Distribution.

(a) By Ordinance 26 of 1935 permits or authorisations for the use or possession of the dangerous drugs are only granted to medical practitioners, dentists, pharmacists and veterinary surgeons.

(b) The Senior Medical Officer or any officer of the Medical Department authorised by him or the Superintendent of Police or any police officer authorised by him have power to enter the premises of any medical practitioners, pharmacists, dentists or veterinary surgeons to verify their books or registers and to inspect their stock of dangerous drugs.

1. If any one fails to produce or conceals or attempts to conceal such books, documents, drugs or stocks of dangerous drugs he is guilty of an offence against Ordinance 26 of 1935.

2. All drugs imported into the Colony are deposited in the Government Store.

Drugs thus stored are not delivered or withdrawn therefrom except on the written authority of the Senior Medical Officer or any officer of the Medical Department authorised by him.
