STATUTORY RULES AND ORDERS, 1946, No. 14.

[16th March, 1946.]

1. **Short Title.** This Order may be cited as the Dangerous Drugs Order, 1946.

2. **Application of Part V of the Ordinance.** Whereas subsection (2) of section 13 of the Dangerous Drugs Ordinance, 1938, power is conferred on the Governor in Council to declare that Part V of the Dangerous Drugs Ordinance, 1938, shall apply to any drug of whatever kind in the same manner as it applies to the drugs mentioned in subsection (1) of the said section 13 if it appears to the Governor in Council that the drug is or is likely to be productive, if improperly used, or is capable of being converted into a substance which is, or is likely to be productive, if improperly used, of ill effects substantially of the same character or nature as or analogous to those produced by morphine or cocaine;

AND WHEREAS it appears to the Governor in Council that the sulpha drugs and barbiturates are productive, if improperly used, of ill effects substantially of the same character or nature as or analogous to those produced by morphine or cocaine:

Now, THEREFORE, the Governor in Council, in pursuance of the powers conferred by subsection (2) of section 13 of the Dangerous Drugs Ordinance, 1938, is pleased to order and declare, AND IT IS HEREBY ORDERED AND DECLARED that Part V of the Dangerous Drugs Ordinance, 1938 shall, after the 31st day of March, 1946, apply to the sulpha drugs and barbiturates in the same manner as the said Part V applies to the drugs mentioned in subsection (1) of section 13 of the Dangerous Drugs Ordinance, 1938.

Made by the Governor in Council under subsection (2) of section 13 of the Dangerous Drugs Ordinance, 1938 (No. 20 of 1938) this 8th day of March, 1946.

*Dangerous Drugs (Cocaine, Morphine, etc.)
(Amendment) Regulations*

STATUTORY RULES AND ORDERS, 1946, No. 15.

[16th March, 1946.]

1. **Short Title.** These Regulations may be cited as the Dangerous Drugs (Cocaine, Morphine, etc.) (Amendment) Regulations, 1946 and shall be read as one with the Dangerous Drugs (Cocaine, Morphine, etc.) Regulations, 1940 (S.R. & O. 1940, No. 35) hereinafter referred to as the principal Regulations.

2. **Amendment of regulation 3 of principal Regulations.** Regulation 3 of the principal Regulations is hereby amended by the addition after paragraph (d) thereof of the following paragraph:—

“(e) Sulpha drugs and barbiturates”.
